CONDITIONS OF PLAY

1. The Tournament Official on duty please read out the Conditions of Play at all venues before players proceed to the greens.

Clubs must ensure that their Tournament Officials have a copy of this

document

2. <u>Points:</u>

- 2 pts for a win
- 1 pt. for a peel
- **3.** A reserve can be declared, but at all times one of the original entrants must be a player.
- 4. Where the competition is staged over a number of days or weekends and no reserve has been nominated on the declaration form. or a reserve has been nominated but is not available to play the next round of the competition, the team concerned may, within 48 hours after the completion of that days or weekends play, approach the Competition Secretary to allow the introduction of another reserve. The Competition Secretary will not unreasonably refuse such a request providing it is for a valid reason.

If no request was received by the District Competitions Secretary timeously a substitute will be drawn off the bank, this substitute will not be allowed to play Skip.

5. No Burnt ends the jack will be spotted on the 2 metre mark.

6. <u>Withdrawal of a player</u>

Should a player/team withdraw at any time after commencement with or without the consent of the Controlling Body, all their completed results shall stand up to the point of withdrawal. That game and the remainder of the games shall be forfeited and the opposing player/s for that and the remaining unplayed games shall be allocated **full** points.

7. Round Robin Trial ends:

Two trial ends allowed (two bowls up and two bowls down)

No further trial ends unless direction of play is changed

8. Knock-out Rounds:

Two trial ends allowed with each game (two bowls up and two bowls down)

Times:

Please note the times noted are guidelines only and if games can start earlier it is allowed.

Inclement weather:

In the event of inclement weather, 50% of the ends to be played + 1 end constitutes a game (e.g. over 15 ends you need to play 9 ends, over 18 ends you need to play 10 ends, over 21 ends 11 ends). In the event of the required number of ends not played, points will be shared.

Consumption of Alcohol

The consumption of alcohol during a playing session in any district organized event is totally prohibited.

Any player to be found transgressing this rule shall be reported to his/her club who will duly deal with the transgression and notify the Executive of such outcome. Should a further transgression take place this will be reported to the Executive who will deal with it and the outcome submitted to the member's club.
